

Affiliate Program Terms and Conditions

Welcome to the Al Noor Carpet & Curtains Affiliate Program! We are excited to have you as a part of our team. Please read the following terms and conditions carefully before participating in our program.

1. Eligibility

1.1. To be eligible to participate in the Al Noor Carpet & Curtains Affiliate Program, you must be a previous customer of Al Noor Carpet & Curtains.

1.2. By applying to become an affiliate, you confirm that you have purchased from Al Noor Carpet & Curtains and can provide proof of purchase upon request.

2. Commission Structure

2.1. Affiliates will earn a 10% commission on all sales generated through their referrals, with certain limits as described below.

2.2. There is a maximum commission limit of 500 AED per sale, regardless of the total sale amount. For example:

- A sale of 5,000 AED will yield a commission of 500 AED.
- A sale of 50,000 AED will also yield a commission of 500 AED.

2.3. For sales below 5,000 AED, the 10% commission applies. For example:

- A sale of 1,000 AED will yield a commission of 100 AED.
- A sale of 3,000 AED will yield a commission of 300 AED.

3. Referral Process

3.1. Affiliates must personally contact Al Noor Carpet & Curtains prior to referring a customer.

3.2. The affiliate must inform Al Noor Carpet & Curtains about the referral beforehand, providing details of the potential customer.

3.3. Failure to notify Al Noor Carpet & Curtains before the referral will result in the affiliate not receiving any commission for the sale.

4. Application and Approval

4.1. All affiliate applications are subject to approval by Al Noor Carpet & Curtains.

4.2. Once your application is approved, you will receive an email with detailed instructions on how to begin promoting our products and earning commissions.

5. Payment Terms

5.1. Commissions are calculated based on the net sales generated through your referrals, excluding taxes, shipping, and returns.

5.2. Payments will be made on a monthly basis via the payment method specified in your affiliate account.

6. Promotion and Ethics

6.1. Affiliates are expected to promote Al Noor Carpet & Curtains in an ethical and professional manner.

6.2. Misleading, false, or inappropriate advertising is strictly prohibited and may result in termination of your affiliate status.

7. Termination

7.1. Al Noor Carpet & Curtains reserves the right to terminate an affiliate account at any time for any reason, including but not limited to violation of these terms and conditions.

8. Changes to Terms

8.1. Al Noor Carpet & Curtains reserves the right to update or modify these terms and conditions at any time. Affiliates will be notified of any significant changes.
